

Geraldton Universities Centre provides access to our facilities for students studying in Commonwealth Supported University programs. Use of the facilities, including GUC's wifi and 24 hour study space, is within the following conditions:

1. Students must sign this policy on their first visit, fill in the student registration form and present a student ID card or driver's licence plus proof of enrolment (enrolment advice) with an Australian university.
2. A wifi password and GUC student card will be issued entitling the student to access the 24 hour study space and the GUC printer and photocopier. (Charges apply for printing with students able to put money on the student card for this purpose at reception.)
3. Study facilities are available in all student common areas of the GUC (not classrooms), including the 24 hour study hall.
4. Access to wifi is for study purposes only. Download is monitored and if excessive, access may be denied.
5. All students are required to respect the rights of other students when studying, keeping noise and the spreading out of study resources to a minimum.
6. Study areas must be left in the condition they are found in (eg chairs pushed in, desks returned to original position if moved, no rubbish, etc). Failure to do so may result in future access to GUC facilities being denied.
7. GUC library books are closed reserve only (ie not available for external borrowing). They may be signed out to read in other areas of the GUC by taking the card at the back of the book to reception.
